Nahendran Navaratnam practices as a barrister in Navaratnam Chambers and an Arbitrator at Navaratnam Arbitration Chambers. He is a graduate of Monash University, Australia and holds a Bachelor of Science in addition to a law degree. Nahendran was called to the Malaysian Bar in 1988 and has wide experience handling trials, appeals and arbitrations in corporate, commercial and administrative law disputes for both private and public listed companies, major financial institutions and multinational corporations. He also sits as a Chartered Arbitrator and is an accredited Mediator and Adjudicator.

Nahendran acts in complex commercial and company law disputes. These include disputes involving financial and fraudulent malfeasance, contractual disputes in oil and gas, energy, technology, project financing, construction design, commercial services, statutory disputes and administrative law. His degree in Materials Science provides a significant advantage in disputes involving technical issues.

He is especially conversant with issues involving statutory and contractual interpretation and with regulatory, licensing and enforcement schemes in the securities industry, telecommunications, water and energy sectors.

Nahendran is a Chartered Arbitrator.
